PRESENTATION:

Alamycin Aerosol is a stable, sterile non-aqueous solution for topical administration containing 35.8 mg/g **OXYTETRACYCLINE HYDROCHLORIDE**, complexed with magnesium chloride and polyvinylpyrrolidone (PVP).

INDICATIONS:

Oxytetracycline is active against a wide range of Gram-positive and Gram-negative pathogenic bacteria, certain *Mycoplasma*, rickettsiae, protozoa and *Chlamydia*.

Alamycin Aerosol is indicated for the treatment of superficial infections of the foot and skin in cattle, sheep and pigs caused by organisms sensitive to oxytetracycline.

DOSAGE & ADMINISTRATION:

For topical use only. Shake before use. Remove any dead tissue, dried serum or secretions and debris from infection site. Hold aerosol upright approximately 8-15cm from the surface and cover affected areas completely once or twice daily for 3-5 days.

The blue marker dye scours out of wool, thus Alamycin Aerosol is suitable for use on fibre-producing animals.

It is an offence for users of this product to cause residues exceeding the relevant MRL in the Food Notice: Maximum Residue Levels for Agricultural Compounds.

MEAT: Cattle, Sheep and Pigs: Nil

Handling Precautions:

May be harmful if swallowed, inhaled or absorbed through the skin. May cause mild skin irritation and eye irritation. Oxytetracycline hydrochloride may possibly affect development and/or reproduction. Methanol may affect the liver.

Wash hands and exposed skin before meals and after use. Do not inhale vapour. Avoid skin and eye contact. Do not spray near heat/sparks/open flames/hot surfaces or other ignition source. No smoking. Pressurized container: Do not pierce or burn, even after use.

First Aid:

If swallowed do NOT induce vomiting. If skin or hair contact occurs remove contaminated clothing and flush skin and hair with running water. If splashed in eyes wash out immediately with water. For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately.

Environmental protection:

Toxic to aquatic animals with long lasting effects. Avoid contamination of any water supply with product or empty container.

Disposal:

Dispose of product and packaging at an approved landfill or equivalent facility.
